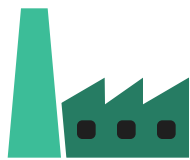

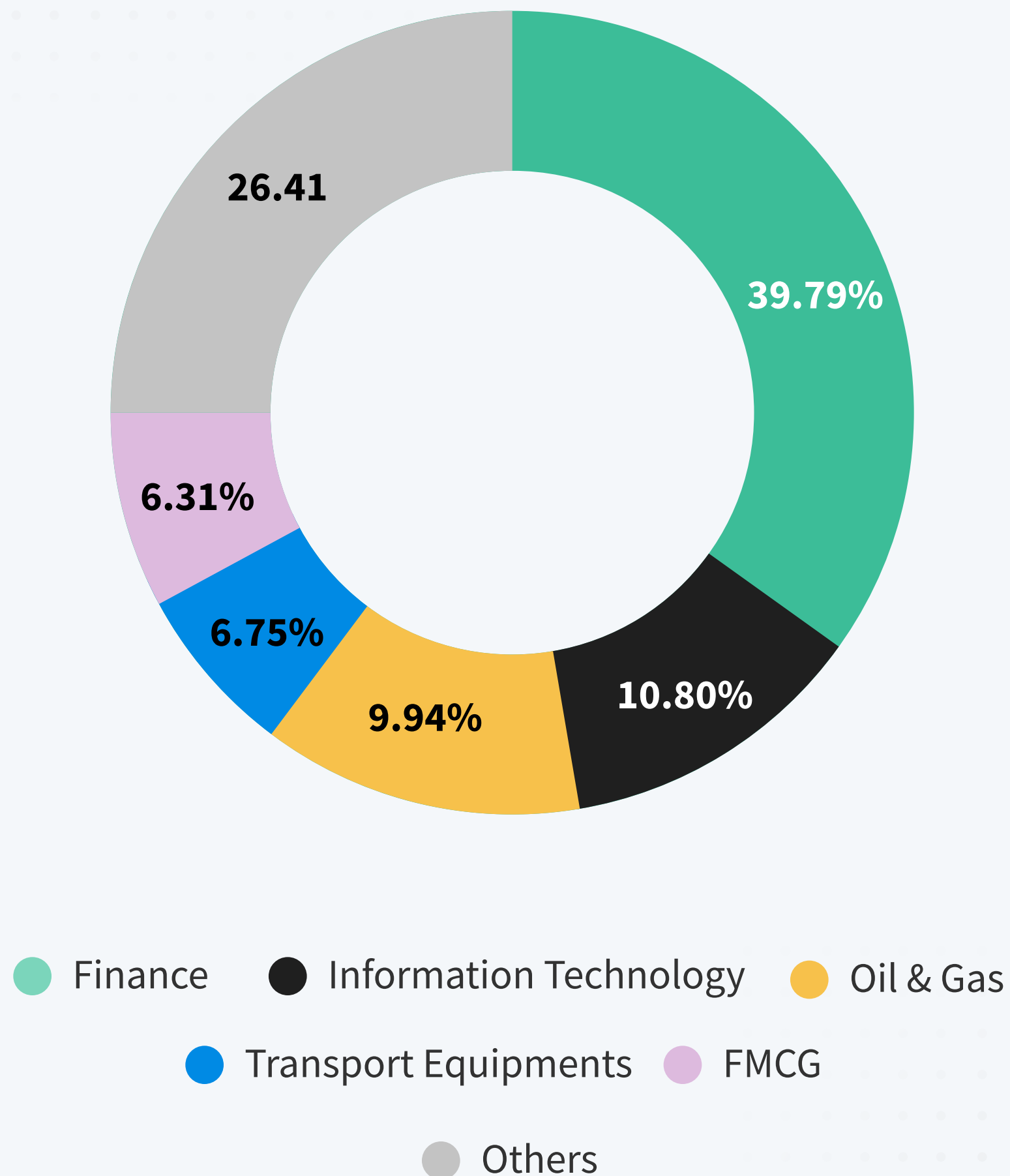

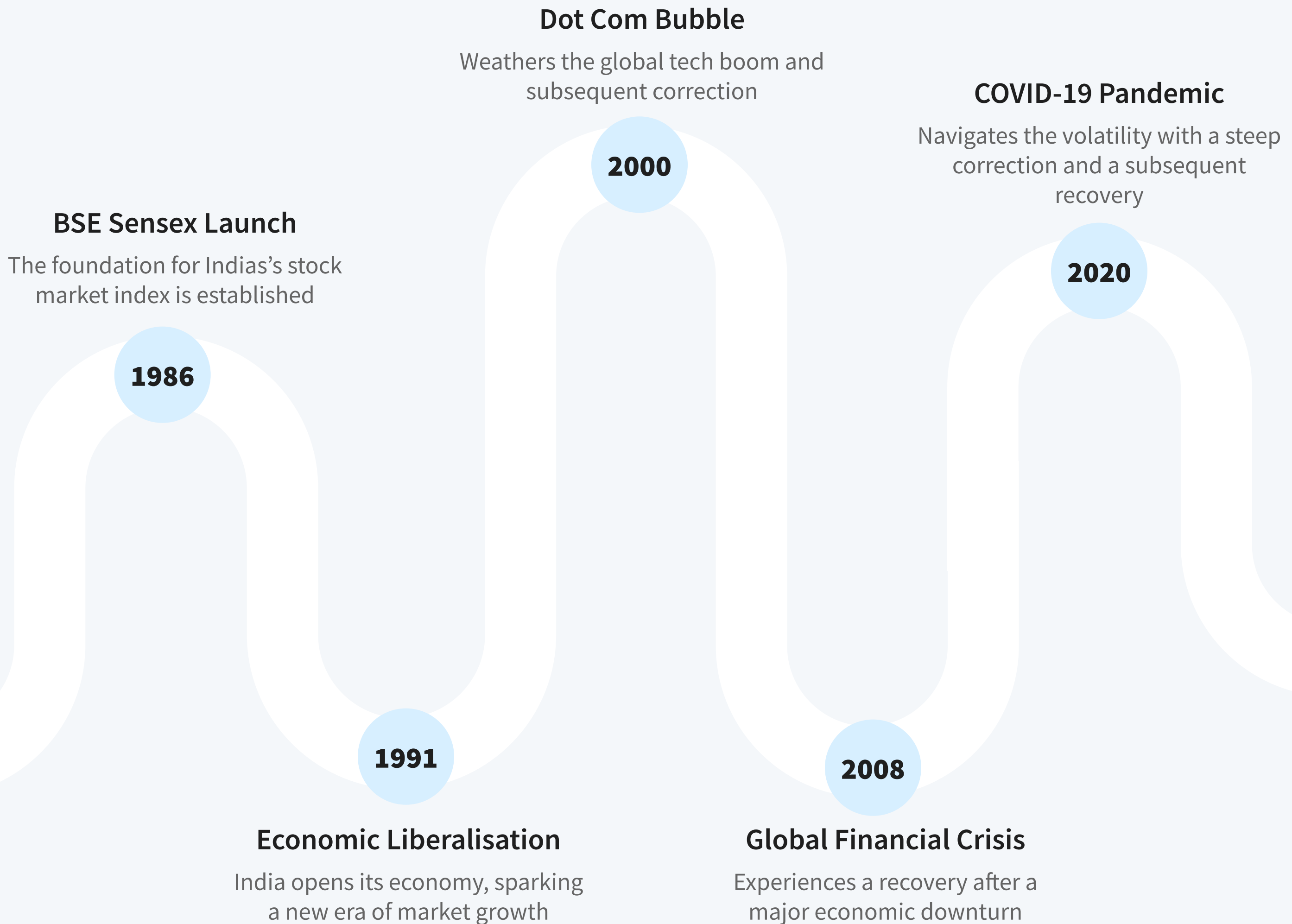

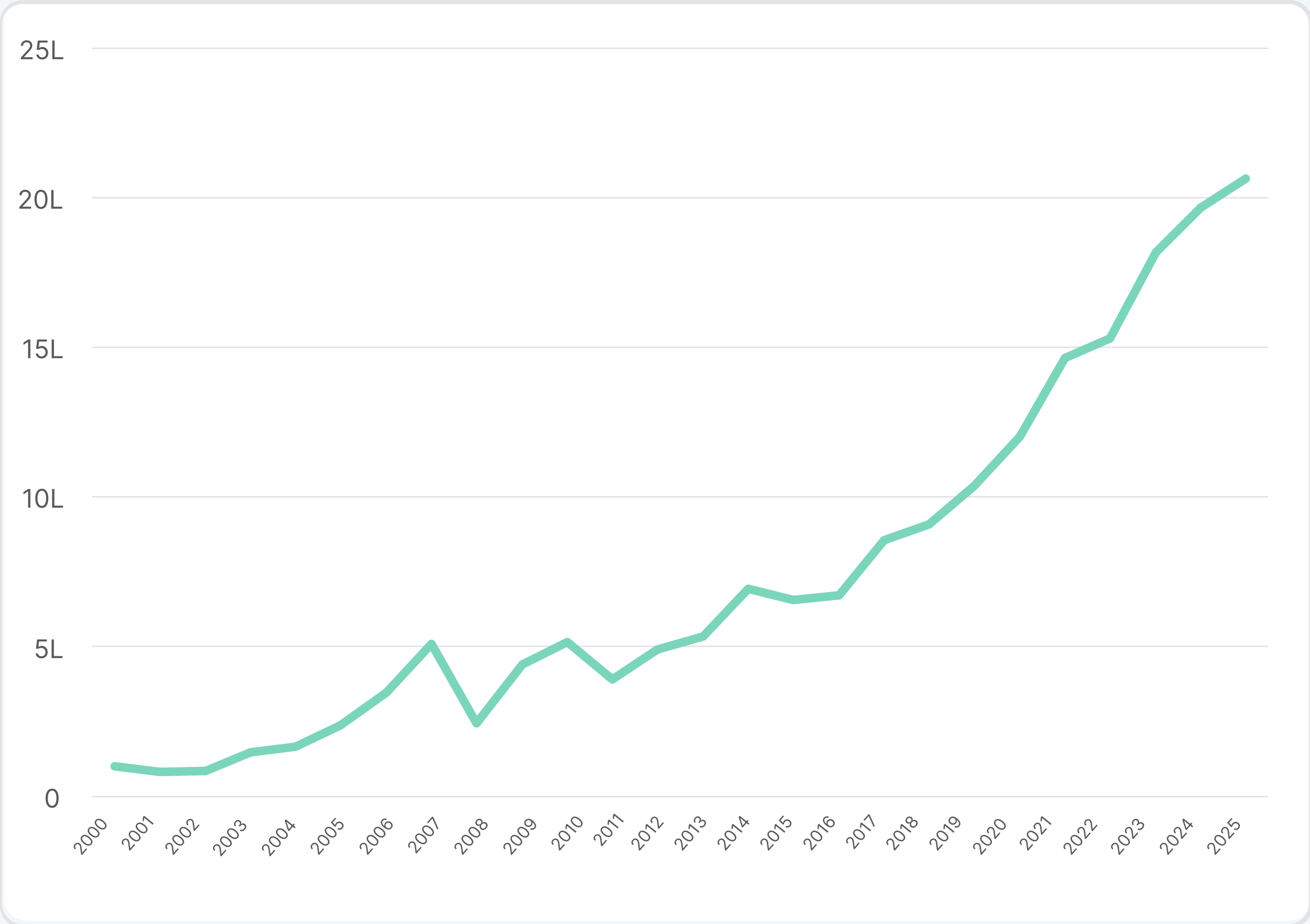

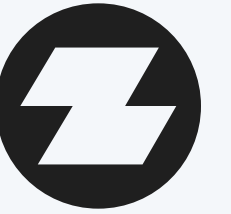
Backed By Decades Of Performance
